Further, the Applicant acknowledges the obligation to remove the temporary outdoor dining area and restore the area to the previous condition as a condition of the issuance of this registration. Finally, the Applicant acknowledges that the requirements contained herein are subject to change based on further guidance from the Governor or the IDPH and any temporary outdoor seating area is required to comply with any such forthcoming guidance even if more restrictive than the Village's regulations. Lastly, nothing herein shall be construed as waiving any immunities the Village may assert in response to or defense of any claims.
